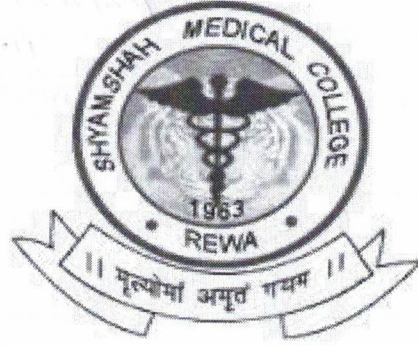

The tenderer firm must have at least five year experience and certified expertise of maintenance support as well as supply of different types of accessories in respect of CCTV in the Central Govt./ State Govt./ Govt. undertakings/ Autonomous Bodies/Semi-Govt/Govt./Hospital/institutions etc. Selected firm will have to render operational and comprehensive annual maintenance for the CCTV system of this office subject to adherence of the following terms and conditions.

1. **Period of Contract** CMC shall be for a period of 02 year from the date of issuance of award of contract/work order. First order will be given for one year. After completion of satisfactory work for one year it shall be extended for next year on same rate. CMC for all items may be extended for future period, if required, at same rate, terms and conditions, at the discretion of this office, subject to satisfactory performance of the agency.
2. **Credentials of the bidder-** The bidder must have at least one year experience during last 5 year for rendering maintenance service of CCTV at least Rs 20 Lakh/ Work order for CMC of CCTV more than Rs 10 lakh as well as supply of different types of accessories in respect of CCTV in the Central Govt./ State Govt./ Govt. undertakings/ Autonomous Bodies/Semi-Govt/Govt./Hospital/institutions etc.. Documents in that respect and work completion certificate must be attached.
3. **General Condition Of Contract**
 - 3.1 All CCTVs (OLD/NEW) shall be taken on “as and where installed” basis in running condition.
 - 3.2 The contractor shall ensure that all CCTV cameras to be in working conditions at the time of taking over present non-functional cameras.
 - 3.3 After completion of the contract, contractor shall hand over the system in perfect running condition (complete in all respects as per inventory)
4. **Commencement of Work** The Contractor is required to start the work within 7 days from the date of award/date of communication of acceptance of the tender. In case it is found that the work has not been taken up within 7 days from the date of acceptance of the tender or issue of the work order, the Hospital Authority may cancel the work order and forfeit the Security Deposit, deposited along with tender without any reference to the Contractor.
5. **Condition of Providing Manpower for surveillance and monitoring of CCTV camera footage in server room**

*** Tenderer must arrange Operators for surveillance & monitoring purpose of CCTV footage at SSB block and SGM hospital. Scope of work will be all premises under SSMC/GMH/SGMH/SSB BLOCK Rewa***

OPERATOR'S RESPONSIBILITY

- Daily cleaning and maintenance according to service programmed in operator's manual.
 - To keep the CCTV Cameras, TV Sets, NVR and all other equipments neat and clean.
 - To Inform the hospital authority if there is any problem in cameras or in any other equipments related to the operation/ surveillance System.
 - To maintain co-ordial relations with hospital management, Staff and authorities.
 - Shall clean all the lenses of the cameras.
 - All breakdown called to be attended promptly.
6. **The penalty amount per complaint will be as follow :**
- 6.1 Minor Faults (not rectified within 24 hour @ Rs 500/- per day.)
 - 6.2 Major faults (not rectified without valid reason within 72 hours @ Rs 1000/- per day.)
 - 6.3 In extreme cases, the action of forfeiture of security money/pending bill/blacklisting of the firm can be resorted at the discretion of the competent authority in case of failure by the contractor to rectify the complaints within the specified time.
 - 6.4 Any damage to building or the part of the equipment during the operation must be repaired by the contractor.
7. In case cctv operator found absent from his duty following recovery shall be made from the tenderer's bill a) Operator @ Rs 300/- per person.

Scope of the work

- Service Provider will have to maintain and repair all hardware equipment related to CCTV. The annual maintenance contract is comprehensive including repair and replacement of defective parts, no separate bills shall be accepted from the service provider for any hardware & other item repairing or replacement pertaining cctv systems.
- Service provider will do the following before implementation -
 - a. will conduct detailed study of the requirements and perform a site survey.
 - b. examine and determine the requirements

Implementation

- a) Successful bidder will be responsible for the complete and comprehensive maintenance of cctv system including cameras and work station configuring and providing assistance to the personnel in understanding and operating the system. Diagnose the faults and rectify the defect detected (as mention page no.4 s.no. 6- **The penalty term and conditions:**)
- b) Repair/Replace the faulty part with same or more superior branded spare parts within 24hrs, no spares or other item will be provided by Hospital Authority.
- c) Carry out periodic checks and determine if any modification are to be made to better suite the working of CCTV work station at the premises in the future, and implement those modification as required with prior approval of the Hospital Authority.
- d) Preventive maintenance should be done on monthly basis and report of the same is required to be submitted to the Office of Dean/Superintendent, SGMH/GMH/SSB, REWA

Annexure C

Terms and Condition

1. The work consists of comprehensive maintenance and repair of CCTV system installed at SSMC/GMH/SGMH/SSB BLOCK in accordance with technical specification, terms and condition mentioned in tender documents.
2. The firm/Company must be registered with the registrar of Companies. The registration number of firm along with the GST registration number must be given in the tender bid. (Enclose necessary documents).
3. Certificate of authorized channel partner for sale and service of CCTV systems.
4. Conditional/ Unsolicited tender shall not be considered.
5. It shall be ensured that the spare parts/ items used for repair and maintenance are fault free (free from material, workmanship and manufacturing defects). The goods supplied shall be of the highest quality, consistent with the established and generally accepted standard.
6. Interested Bidders/ Parties/Firms should visit SSMC/GMH/SGMH/SSB BLOCK and inspect the CCTV systems installed before submitting the quotation and any query or clarification sought for ; they may approach superintendent.
7. The SSMC/GMH/SGMH/SSB BLOCK administration will not be responsible for any loss or damage to service providers material, equipments, tools etc.
8. Deployment of one trend technician during office hour. The onus of verification the attendants of the person deputed rests with the contractor/service provider and the contractor/service provider will be held responsible for any act of omission or mishap on the part of person deputed.
9. If the person deputed by contractor/service provider is found to be absent on his duties or not available at duty, daily wages will be deducted from the monthly bill of the contractor/service provider.
10. No other person except contractor/service providers authorised representative shall be allowed to enter the office premises.
11. In regard to the personal working in SSMC/GMH/SGMH/SSB BLOCK
 - a) The service provider should strictly follow the labour laws, minimum wages act , EPF, ESIC and other allied acts. The service provider should directly deal with the concerned department. The SSMC/GMH/SGMH/SSB BLOCK will not be responsible for any default.
 - b) The service provider will be fully responsible for safety, welfare and any accident during the work. The SSMC/GMH/SGMH/SSB BLOCK will not be responsible at any time.
 - c) The service provider shall not be entitled to make any claim whatsoever against the SSMC/GMH/SGMH/SSB BLOCK under or by virtue of or arising out of these contract, nor shall the SSMC/GMH/SGMH/SSB BLOCK entertain or consider any such claim, if made by the service provider.

- d) The service provider should provide proper uniform with company name.
12. Tenderer will have submit EMD online. After agreement 3—5% performance guarantee demand draft to be submitted in the name of CEO & DEAN SSMC Rewa.
 13. The service provider should quote the price for providing complete annual maintenance SSMC/GMH/SGMH/SSB BLOCK will not pay any advance or extra amount which is not mention in the financial bid.
 14. The successful service provider shall sign an agreement within 7 days of the receipt of order as prescribed by the SSMC/GMH/SGMH/SSB BLOCK accordance with term and condition of the tender on a Rs. 1000.00 non-judicial stamp paper. All legal expenses incidental thereto shall be borne by the service provider.
 15. The TDS will be deducted as per provision of the income tax law.
 16. Hospital authority is not bound to accept the lowest tender and also reserve the right to reject any or all tender at any time without assigning any reason.
 17. SSMC/GMH/SGMH/SSB BLOCK taking note of overall fact and circumstances can change add and relax any of the term and condition of his tender notice.
 18. The contract will be for maximum period of 1 year and the hospital authority reserve the right to extend the contract further subject to satisfactory performance of the contractor.
 19. Hospital authority reserve the right to terminate the contract at any time after giving due notice to the contractor in the event of unsatisfactory service or breach of contract at any respects the performance security amount will be forfeited accordingly.
 20. As per govt. norms/NMC guidelines work to shall be assigned to tendered/service provider/contractor .
 21. After termination of tender agreement tenderer will have to hand over "OK" report of all cameras and accessories in working condition and get NOC for the same.
