I. Scope of Work: To provide high level of fire protection service including day to day management of the fire station, monitoring of activities, training and crisis management Operation, testing, maintenance (upkeep), and miscellaneous related works of the installed fire safety systems and equipment—such as firefighting systems, fire alarm systems, fire extinguishers, etc.—at Shyam Shah Medical College, S.G.M.H., G.M.H., O.P.D., Super Specialty Block Hospital, and all associated hostels.

A. Provision of Trained and Qualified Manpower

1. The personnel of the fire fighting team shall be required to perform the following activities:

- i. Operation, testing, and maintenance of the fire pumps, hydrant system (internal and external), sprinkler system, automatic fire alarm system, and smoke detector system installed at the Super Specialty Block Hospital, Rewa.
- ii. Operation, testing, and maintenance of the automatic fire alarm system and smoke detector system installed at SGMH Rewa.
- iii. Operation, testing, and maintenance of firefighting equipment such as fire extinguishers, etc.; installed at Shyam Shah Medical College, S.G.M.H., G.M.H., O.P.D., Super Specialty Block Hospital, and all associated hostels.
- iv. Participation in mock drills / evacuation drills / fire drills and all other fire safety-related activities. Fire mock drills shall be conducted once every three months.
- v. Daily checking of turn-out (attendance/response) in three shifts, and maintenance of proper records.
- vi. In the event of a fire incident, participation in firefighting and rescue operations shall be mandatory. This shall include coordination with members of the firefighting team, identification of fire hazards, participation in fire incident investigations, preparation of fire incident reports, maintenance and distribution of records related to refilling of fire extinguishers and spare parts. The concerned person shall maintain the ledger, and records shall be updated regularly. The bidder shall ensure proper storage of refilled cylinders and other materials, and separate bin cards shall be maintained for each item.
- vii. Organizing training and demonstrations on the methods of using different types of fire extinguishers, maintaining records, and providing periodic awareness to all concerned personnel. Ensuring implementation of fire prevention measures in coordination with the Security Department.



2. The bidder shall carry out fire hazard analysis.
3. The firefighting team deployed on duty shall respond and take necessary action on all special calls, rescue calls, and fire calls received from the campus of the college and the associated hospitals and hostels.
4. Manpower requirement for 24×7 continuous operations shall be provided, with deployment in three shifts. Working hours shall be as per the general shift and/or shift duty in accordance with the indicative manpower requirement table given in this tender. The bidder shall ensure that the required number of firefighting personnel of various categories are available round-the-clock.
5. Members of the firefighting team shall be required to work anywhere and at any location within the premises of Shyam Shah Medical College, Rewa, and its associated hospitals/buildings.
6. Coordination and supervision of the firefighting team shall be included within the scope of work of the bidder.
7. The bidder shall provide the personnel deployed for the above work with necessary personal protective equipment (PPE) and two (02) sets of uniform bearing the company logo, and shall ensure their use while on duty at site. The uniform shall include red T-shirt and black trousers, fire-resistant dungaree, fire helmet, safety shoes, gumboots and other firefighting related items/equipments including all personal fire protective gears.
8. Only qualified and physically fit personnel shall be deployed for duty.

B. Annual Maintenance of Existing Fire Safety Systems (AMC) Annual Maintenance Contract (AMC) shall be carried out for the existing fire safety systems installed at

1. Fire Officer/Fire Engineer (Highly Skilled)

a)Qualification: B.E. in Fire Technology or B.Tech in Fire & Safety Engineering from a recognized institution / university. (Regular) both

Work Experience:The **Fire Officer/Fire Engineer** must have a minimum of 02 (two years) work experience in an Autonomous Hospital / (Government / Semi-Government / Non-Government / Corporate Hospital / Private Hospital / Trust or PSU), along with a photocopy of the above-mentioned degree from a recognized institution/university.The concerned hospital must have a minimum capacity of 500 (five hundred) beds, and the building height must be at least 15 (fifteen) meters.

3. Fire Supervisor

a) Qualification: 02 year Diploma Course Fire & Safety Engineering/certificate course for 1 year from recognised university (Regular) both.

Work Experience: Diploma holders must have at least 01 (one years) work experience in an Autonomous Hospital / (Government / Semi-Government / Non-Government / Corporate Hospital

/ Private Hospital / Trust or PSU), along with a photocopy of the above-mentioned degree from a recognized institution/university. The concerned hospital must have a minimum capacity of 100 (one hundred) beds, and the building height must be at least 15 (fifteen) meters.

5. Maintenance Technician –(Skilled)

a) Qualification: I.T.I. (ITI) / Diploma in Mechanical / Fitter / Pump Mechanics

Work Experience: Minimum 01 (One) year experience in maintenance and repair of fire and safety equipments systems, including pumps, piping, valves, motors, and other of fire and safety equipments systems, with working knowledge of mechanical drawings, tools, and equipment. practical experience in the maintenance and repair of electrical panels, motors, cabling, lighting, pumps, control systems, etc.

7. Rescue Personnel (Unskilled)

a) Qualification: The candidate must have passed at least 10th standard and should be able to read and write Hindi or English properly.

Work Experience: Minimum **06 months** experience in fire safety works in a hospital / reputed firm / industrial establishment/building height must be at least 15 (fifteen) meters.

1. Duties of Fire Officer/ Duties of Fire Engineer

a) The agency shall be responsible for preparing the Fire Safety Plan for the concerned buildings, with reference to the existing plans available at Shyam Shah Medical College, S.G.M.H., G.M.H., O.P.D., and the Super Specialty Block Hospital.

b) The Fire Safety Plan shall be prepared in consultation with the local Fire Brigade and the concerned Electrical / Mechanical departments. Any deficiencies or faults in the fire alarm system, firefighting system, and public addressing system shall be rectified at the earliest.

c) He shall ensure that all fire safety equipment and systems are always operational and maintained in good working condition for immediate use.


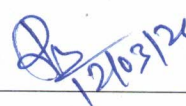
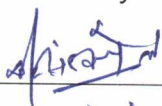
d) He shall be responsible for establishing effective coordination with members of the firefighting team and security personnel.

e) In coordination with the Security Department, he shall ensure implementation of fire prevention measures. In the event of any fire emergency, he shall establish Incident Command and issue necessary instructions to the firefighting team and security personnel for fire suppression and safe evacuation.

f) He shall supervise pump drills, ladder drills, and other firefighting exercises.

g) Whenever required, he shall liaise with and call for assistance from the District Municipal Corporation / Fire Brigade.

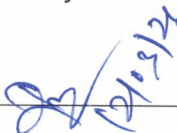
h) He shall identify fire hazards.



- i) He shall participate in fire incident investigations and prepare the Fire Report.
- j) He shall organize fire mock drills with the assistance of the local Fire Brigade at least once every six (06) months and at least once every month in all buildings, including hospital buildings, medical college, College of Nursing, auditorium, library, MBBS UG Boys' Hostel, MBBS UG Girls' Hostel, PG Hostel, Nursing Hostel, and all other buildings. These drills shall include testing of the fire alarm system, smoke detection system, fire MCPs, fire hose reels, fire hydrant system, and practical live-flame testing of sprinklers designed to operate at 68°C.
- k) He shall be responsible for the maintenance, upkeep, and overall supervision of all installations related to the fire alarm system, firefighting system, and public address (PA) system, including monitoring of the entire staff and systems.
- l) Operation, testing, and maintenance of the fire pumps, hydrant system (internal and external), sprinkler system, automatic fire alarm system, and smoke detector system installed at the Super Specialty Block Hospital, Rewa.
- m) He shall ensure proper storage of refilled extinguishers and other materials in the store and maintain separate bin cards for each item.
- n) Preparation of the monthly duty roster and inspection of staff reporting for duty. He shall also brief personnel regarding their duties. The duty roster must be jointly certified by the Fire Officer, and a hard copy of the roster shall be submitted to the official office of the College/Institution.
- o) Taking attendance in each shift and submitting a monthly attendance hard copy, duly jointly certified by the Fire Officer and the bidder, to the College Authority shall be mandatory. In case of absence, immediate arrangement of a substitute shall be made, and the College Authority shall be informed in writing.
- p) He shall provide fire safety training to the Fire Supervisors / Firemen staff.
- q) He shall be responsible for the procurement, accounting, and issuance of refilling of firefighting equipment and spare parts. He shall maintain the ledger and ensure regular updating of records.

3. Duties of Fire Supervisor

- a) He shall be responsible for the maintenance, upkeep, and care of all installations related to the fire alarm system, firefighting system, and public address (PA) system, as well as for supervision of the entire staff and systems.
- b) In the event of any fire incident, he shall carry out firefighting operations and ensure the safe evacuation of occupants present in the building.
- c) In case of fire, he shall take command of firefighting and evacuation operations. He shall remain stationed in the control room and issue necessary instructions to floor wardens and other concerned personnel through the public address system / telephone. He shall also



ensure that the Fire Brigade has been informed of the incident. Upon arrival of the Fire Brigade, he shall guide them to the affected floor and carry out further actions as per their instructions.

- d)** The maintenance records / checklists for fire sprinklers installed inside the hospital buildings shall be prepared in the prescribed format (Annexure–V) and submitted mandatorily every month by the vendor/agency to the office of the Fire Nodal Officer.
- e)** The maintenance records / checklists for all fire extinguishers installed in the premises of Shyam Shah Medical College, S.G.M.H., G.M.H., O.P.D., and the Super Specialty Block Hospital shall be prepared in the prescribed format (Annexure–VI) and submitted mandatorily every month by the vendor/agency to the office of the Fire Nodal Officer.
- f)** The maintenance records / checklists for all fire hose reels and fire hydrants installed in the Super Specialty Block Hospital premises shall be prepared in the prescribed format (Annexure–VII) and submitted mandatorily every month by the vendor/agency to the office of the Fire Nodal Officer.
- g)** The maintenance records / checklists for the fire alarm system installed in the Super Specialty Block premises shall be prepared in the prescribed format (Annexure–VIII) and submitted mandatorily every month by the vendor/agency to the office of the Fire Nodal Officer.
- h)** He shall be responsible for the operation of the Fire Control Room.
- i)** He shall also ensure that the fire station premises are kept clean and that all equipment and appliances are always maintained in proper working condition for immediate use.
- j)** Whenever required, he shall inform the District Municipal Corporation / Fire Brigade and call for assistance.
- k)** He shall be responsible for proper accounting of all equipment, gear, and other materials within the hospital premises. In case of damage or loss of any equipment, he shall immediately inform the Fire Officer and initiate necessary preventive/corrective actions.

4. Duties of Fireman

- a)** The Fireman / Assistant Fireman shall be familiar with the fire alarm system, firefighting system, public address system, and the firefighting equipment, exit routes, and escape routes installed on each floor. If any damage or defect is noticed in any equipment or system, the same shall be immediately reported to the Fire Officer / Fire Engineer.
- b)** He shall ensure that the escape routes are free from any obstruction. If any obstruction is found, arrangements shall be made to remove it immediately.
- c)** In the event of a fire or activation of the fire alarm, the Fireman shall locate the seat of fire and take necessary action to extinguish the fire using the available firefighting equipment. He shall also ensure that the incident is immediately reported to the Fire Supervisor. If evacuation is required, he shall organize evacuation activities on the floor. Prior to evacuation, the Floor



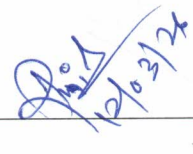

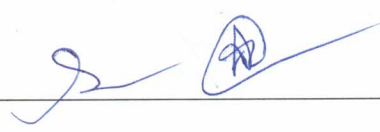
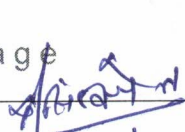
Warden shall check the condition of staircases. If smoke is present, alternate staircases shall be used.

- d) Round-the-clock (24×7) availability of staff shall be ensured.
- e) Participation in fire safety training, mock / evacuation / fire drills, and fire rescue operations organized by the Fire Officer and/or Fire Supervisor shall be mandatory.
- f) He shall be required to perform working at height, as well as firefighting and rescue operations.
- g) He shall have thorough knowledge of the geographical layout of the hospitals, hostels, and college campus, so that assistance can be reached promptly wherever required.

Terms and Conditions Required for Submission of Proposal

1. The agency must have at least 01 (one) year of experience in carrying out firefighting installation, fire alarm installation, and Fire AMC (Annual Maintenance Contract) works in a major hospital / government building / State Government / Central Government / Public Sector organization / Multinational Company (MNC).
2. Annual operation, maintenance (AMC), and miscellaneous works of the firefighting system, fire alarm system, and public addressing system installed at Shyam Shah Medical College, S.G.M.H., G.M.H., O.P.D., Super Specialty Block Hospital, and all associated hostels shall be carried out 24×7 in three shifts.
3. Maintenance works shall be carried out in revised form, strictly in accordance with the rules, regulations, and instructions of Shyam Shah Medical College.
4. For the operation and maintenance of the above works, the bidder shall deploy suitably qualified and experienced technical staff as specified. Such staff shall remain on duty on all days of the week, including Sundays and all types of holidays.
5. The firm shall provide the names and qualifications of the personnel deployed in different shifts to the Fire Nodal Officer or his authorized representative.
6. The staff deployed on duty shall mandatorily wear clean uniform, identity card (ID card), and badge. No additional payment shall be made for the uniform. If any employee is found without uniform / ID card / safety shoes, appropriate action shall be taken against him/her as per the instructions of the Hospital Authority.
7. The Department shall have the right to cancel or discontinue the work at any time without assigning any reason. Further, if the performance of the work is found to be unsatisfactory in the opinion of the authority, the Department shall be free to stop or terminate the work.

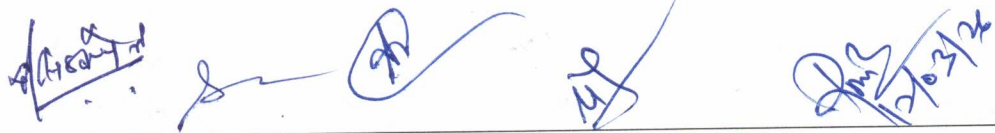
8. This shall include periodic inspection and testing of all installations (equipment) at prescribed intervals, to ensure that they are kept ready at all times for safe operation.
9. The bidder shall arrange its own Tools & Plant (T&P), including fire ladders, welding machine, weighing machine, MICC tool kit, laptop with latest technology, etc. If the bidder fails to provide any of the required tools/equipment, 1% of the Work Done Amount shall be deducted from the monthly bill.
10. If the bidder discontinues the work midway or if the work is stopped due to unsatisfactory performance, the Performance Guarantee and Security Deposit of the bidder shall be forfeited, and the Department may initiate appropriate legal action under the Contract Rules.
11. No worker shall be engaged for more than 8 hours per day. The firm/bidder shall maintain wage records of all workers and shall not pay less than the minimum wages fixed or revised from time to time by the Government of India / Labour Department.
12. Before quoting rates, the bidder/firm is strongly advised to conduct a site visit to correctly assess the quantum of work and location of work.
13. The bidder shall provide communication facilities to the staff deployed in each shift, including a multimedia mobile phone with at least 4 GB RAM and 64 GB storage, and license-free walkie-talkie devices. The minimum operating range of the walkie-talkie shall be 1 kilometre, to ensure proper communication and quick response on site.
14. To ensure that all installations are fully functional, the bidder shall conduct a completed demonstration drill once every month. Prior intimation of the drill date shall be given to the Fire Nodal Officer, and the drill shall be conducted in his presence.
15. The conduct of the workers deployed by the bidder shall be proper and disciplined. If any worker indulges in misbehaviour at the work site, legal action shall be taken by the Department.
16. On completion of the contract period, the firm shall handover the entire system in fully working condition to the next firm. An inventory of systems and installations shall be prepared and signed by both firms. If any discrepancy or deficiency is found at that time, the corresponding amount shall be deducted from the bidder's bill.
17. The bidder shall provide the employees deployed for the above work with necessary personal protective equipment (PPE) and two (02) sets of uniform with the company logo, and shall ensure their use during site operations. The uniform shall include red T-shirt, black trousers, fire-resistant dungaree, fire helmet, safety shoes, and gumboots.



18. The firefighting team deployed on duty shall respond to and take action on all special calls, rescue calls, and fire calls received from the college and the associated hospitals and hostels premises.
19. Performance in mock drills / evacuation drills / fire drills and all other fire safety-related activities. A fire fighting mock drill shall be conducted once every three (03) months.
20. In the event of a fire incident, participation in fire fighting and rescue operations shall be mandatory. This shall include coordination with fire fighting team members, identification of fire hazards, participation in fire incident investigations, preparation of fire incident reports, and accounting and issuance of refilling of fire fighting equipment and spare parts. A ledger shall be maintained and records shall be updated regularly. The bidder shall ensure that refilled extinguishers and other items are properly stacked in the store, and that separate bin cards are prepared and maintained for each item.
21. Organizing training and demonstrations on the methods of using different types of fire extinguishers, maintaining records, and providing periodic awareness to all concerned personnel. Ensuring the implementation of fire prevention measures in coordination with the Security Department.
22. The fire fighting team deployed on duty shall take action on all special calls, rescue calls, and fire calls received from the college and the associated hospitals and hostels premises.
23. For 24x7 continuous operations, firefighting personnel shall be deployed in three shifts. Working hours shall be as per the general shift and/or shift duty, as mentioned in the indicative firefighting manpower requirement table provided in this tender. The bidder shall ensure round-the-clock availability of the required number of firefighting personnel across various categories.

II. Terms and Conditions Required for Submission of Proposal

1. Before submitting the tender, the bidder is advised to fully acquaint himself with all tender conditions, including the etc.
2. The bidder shall submit the tender strictly in compliance with the tender specifications, terms, and conditions as mentioned in the tender document.
3. The bidders are advised to obtain prior permission from the Hospital Superintendent and carry out a physical site inspection before submitting the tender, in order to properly understand the site conditions, nature of work, and method of execution. The rates quoted by the bidder in the tender shall be deemed to be adequate to complete the work in accordance with all instructions and site conditions.
4. The bidder shall clearly quote the prices/rates both in figures and in words. In case of any discrepancy or ambiguity, the rates written in words shall prevail. Any overwriting, insertion,

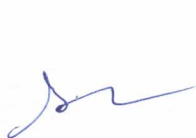

- b. The tender shall be based on a Two-Part System, as detailed below

Part-I: This shall include Technical and Commercial details (excluding the price).

Part-II: This shall include only the Price Bid, to be submitted strictly in accordance with the Price Format provided in Annexure-D. After evaluation of the Technical and Commercial Proposals, the Price Bids of only the eligible bidders shall be opened.

Part-I – Technical & Commercial Bid (Without Price) This part shall include the following details:

- a) Covering Letter of the tender.
- b) Earnest Money Deposit (EMD) documents – (Any tender submitted without EMD shall be rejected).
- c) Tender Fee (if the tender document has been downloaded from the website).
- d) Company Profile Details, including:

10. Procedure / Method for Submission of Tender Both parts of the proposal shall be submitted online through the e-portal only.

11. Contract Period: The contract shall be valid for 36 (thirty-six) months from the actual date of commencement of work after successful site mobilization. Initially, the Work Order shall be issued for a period of 12 (twelve) months. If the performance is found satisfactory, the Work Order shall be renewed for the next 12 months, and similarly continued up to maximum total period of 36 months.

11. Extension of Contract: Subject to the suitability/approval of the College Authority and with the consent of the bidder, the contract may be extended for a further period of up to 01 (one) year after completion of the contract period. In such a case, the bidder shall continue to work as per the original terms and conditions of the contract, and after successful completion of 36 months, the work shall be carried out at the original contract rates.

12. Mobilization Period: Mobilization for commencement of work shall be completed within 15 (fifteen) days from the date of issue of the Letter of Intent (LOI) / Work Order (WO). No mobilization advance shall be payable under this contract.

15. Taxes and Duties: All taxes and duties payable for execution of the contract within the scope of work shall be borne by the bidder, and no extra payment shall be admissible on this account. The rates quoted by the bidder shall be deemed to be inclusive of all taxes and duties. If there is any increase in taxes or duties at any stage during the contract period, the same shall be borne by the bidder. - a. Taxes shall be deducted as per the provisions of the Income Tax Act (I.T. Act). If applicable, Income Tax and Works Contract Tax shall be deducted from the bill.
- b. The bidder shall ensure the daily availability of the exact number of fire service personnel as specified in the contract. In case of absence, a suitable replacement shall be mandatorily provided, and the same shall be intimated in writing to the College Office. Failure to do so shall attract a penalty on the bidder, which shall be calculated as follows:

Number of absent fire personnel × one day's wage

- c. The bidder shall deploy properly authorized, skilled, and qualified personnel and shall ensure the required quality of work. All fire personnel deployed by the bidder shall remain alert at all times during duty. If any personnel are found unsuitable, unqualified, or negligent by the College Authority, the bidder shall immediately remove such personnel and provide a suitable replacement. Failure to do so shall entitle the College Authority to impose a penalty of up to ₹1,000 per day on the bidder.
 - d. The fire personnel deployed by the bidder shall maintain and safely keep all records related to daily inspection of equipment, condition and operational status, training records, mock drills, etc., in the prescribed registers and formats. If the records are found incomplete, or if the required drills and inspections are not conducted within the prescribed time, a penalty of up to 10% of the payable monthly amount for that month shall be imposed on the bidder.
 - e. If the tenderer do not comply with any terms and condition of tender or failed to prevent minor/major fire related incidents, Penalty of minimum INR 20,000.00 (twenty thousand only) or as per actual estimated cost of damage.
- 17. Earnest Money (EMD):** An Earnest Money of ₹1,00,000.00 (Rupees One Lakh only) shall be deposited online. No payment in cash or by cheque shall be accepted. - 18. Performance Bank Guarantee:** After acceptance of the tender, the bidder shall mandatorily submit a Performance Guarantee equivalent to 5% of the total annual contract value, in the form of a Performance Bank Guarantee.

The decision of the College Authority shall be final and binding on the bidder.

22. **Indemnity:** The bidder shall fully indemnify and keep the College Authority harmless against all liabilities, claims, damages, losses, injuries, or accidents arising out of or in connection with the work, whether involving the bidder's employees, any third party, or the College's employees and properties.

23. **Jurisdiction:** Any action, dispute, or proceedings arising out of or relating to this Work Order shall be subject to the exclusive jurisdiction of the courts at Rewa, notwithstanding anything to the contrary mentioned in the tender/quotation.

24. **Safety:** All safety equipment and materials required for execution of the work shall be provided by the bidder at no additional cost. The bidder shall ensure that no damage, loss, or injury is caused to any person, third party, or equipment due to execution of the work.

IV. Special Terms and Conditions of Contract

1. The working height shall vary from location to location and may be 20 meters or more above ground level.
2. The bidder shall ensure uninterrupted supply of the required manpower on a 24-hour (round-the-clock) basis throughout the year, including Sundays and holidays. **Attendance must be done by biometric device and monthly attendance data verification is to be done by concern superintendent.** No additional payment shall be admissible for work performed on Sundays and holidays.
3. Attendance records of fire personnel and other fire safety-related records maintained by the bidder shall be preserved. The bidder shall maintain all records related to wages, EPF, insurance, etc., and shall submit the same to the College Authority along with the monthly bill. The salary of the fire personnel deployed by the bidder shall be credited directly to their individual bank accounts.
4. The bidder shall maintain a register for accounting of all materials issued, clearly mentioning the details of materials, date of issue, quantity, and purpose of use. Details of materials issued/consumed during each month shall be submitted to the College Authority before the 10th of the following month.
5. A fire station shall be provided within the hospital premises for the firefighting team, where firefighting equipment shall be maintained along with an office.
6. The bidder shall mandatorily issue identity cards (ID cards) to all members of the firefighting team.



- 7. Safety and Custody of Institutional Materials:** The bidder shall be fully responsible for the safe custody and security of all materials issued by the institution. Upon completion of the work or during the course of the work, the bidder shall submit proper accounts of all materials issued by the institution.
- 8. Contract Agreement:** A formal contract agreement shall be executed on non-judicial stamp paper of ₹1,000 within 15 (fifteen) days from the date of issue of the Letter of Acceptance (L.O.A.). No payment shall be made without execution of the contract agreement.
- 9. Responsibility of the Bidder:** During execution of the work, if any accident occurs, or any person is injured, or any property is damaged, the bidder shall be fully and personally responsible. In such cases, the bidder shall pay appropriate compensation as per the Workmen's Compensation Act. The bidder shall also arrange adequate insurance policies at his own level to ensure that all workers deployed are sufficiently covered against accident risks. The bidder shall further ensure that the buyer (College Authority) is fully indemnified and kept free from all claims, liabilities, and expenses arising out of such injury, damage, or loss.
- 10. No Right to Employment:** Engagement of personnel under this contract shall not confer any right of permanent employment or any other claim in the College/Institution. The bidder shall strictly comply with all statutory rules and regulations applicable under the Workmen's Compensation Act while engaging or disengaging workers/employees.
- 11. Labour Relations:** The bidder shall settle all labour-related matters on its own and shall maintain harmonious labour relations at the work site, so that the work is carried out continuously and without interruption.
- 12. Medical Responsibility:** The bidder shall be fully responsible for providing necessary first aid, emergency medical care, or advanced medical treatment to its employees whenever required.
- 13. Illegal Acts at Work Site:** The bidder shall be fully responsible for any illegal acts committed by its employees at the work site, such as sexual harassment of women, intoxication, or any other unlawful activity.
- 14. Statutory Compliance:** The bidder shall mandatorily comply with the provisions of all the following statutory Acts, including but not limited to: the Contract Labour (Regulation & Abolition) Act, 1970; Employees' State Insurance Act, 1948; Workmen's Compensation Act, 1923; Payment of Wages Act, 1936; Employees' Provident Fund (and Miscellaneous Provisions) Act, 1952; Payment of Bonus Act, 1965; Minimum Wages Act, 1948; Employees' Liability Act, 1938; Employment of Children Act, 1938; Maternity Benefit Act, 1961; and all other applicable rules, regulations, or Acts as may be amended or notified from time to time. The College Authority shall have the right, whenever deemed necessary, to seek proof of compliance with the above Acts, and the bidder shall be obliged to furnish the same accordingly. The bidder shall be fully and personally responsible for any violation of the above Acts or any other statutory provisions.
